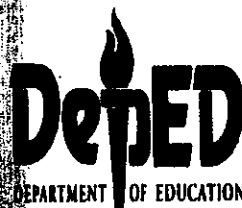

SUBJECT : **"Three-Day Orientation and Training-Workshop of ABOT ALAM Literacy Volunteers and Untrained IMs"**

DATE : April 13, 2015

1. In consonance with DepEd Order No. 17, S. 2014 entitled, "ABOT ALAM PROGRAM" and in response with the objective of achieving the Education For All (EFA) targets and Millennium Development Goals under the implementation of the said program, the Division of Nueva Ecija through the Alternative Learning System will be conducting a "Three-Day Orientation and Training-Workshop of all Abot Alam Literacy Volunteers and Untrained IMs on April 23, 24 and 25, 2015 at DepEd-NE Conference Hall.
2. The said training-workshop aims to:
 - a. orient the Literacy Volunteers on the content of DepED Order No. 17, s. 2014 and the Implementing Guidelines of the said memorandum;
 - b. orient both Literacy Volunteers and Untrained IMs on the teaching assessment tool and teaching approaches/strategies using various ALS modules;
 - c. orient implementers of their roles and functions/responsibilities;
 - d. equip them with the proper preparation of session guides and reports; *and*
 - e. abreast them with the operationalization of the data-base format of the program.
3. The participants are the Literacy Volunteers and Untrained IMs. (Inclosure No. 1).
4. The training is **FREE of registration**. Materials, meals/snacks, travelling expenses and other incidental expenses will be charged against **ABOT ALAM PROGRAM FUND** subject to the usual accounting and auditing rules and regulations.
5. The Participants are advised to bring : laptop/netbook, extension wire and other provisions needed on the 3rd day of the training for the workshop.
