

5. Immediate dissemination of the contents of this Memorandum is earnestly desired.

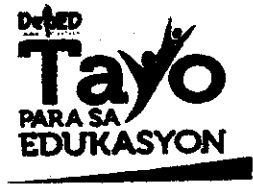
