SUBJECT: **DIVISION SEMINAR/WORKSHOP ON APPROACHES AND TEACHING STRATEGIES (DSWATS) IN SPECIAL EDUCATION (SPED)**

DATE: **May 2, 2017**

1. The Schools Division of Nueva Ecija will conduct a 3-day training entitled "DIVISION SEMINAR/WORKSHOP ON APPROACHES AND TEACHING STRATEGIES (DSWATS) IN SPECIAL EDUCATION (SPED)" on May 30-31 and June 1, 2017 at Conference Hall – Division of Nueva Ecija, Old Capitol Compound, Burgos Avenue, Cabanatuan City.
2. The objectives of the seminar are as follows:
  - 2.1 To provide teachers awareness on the SPED curriculum;
  - 2.2 To introduce to teachers the approaches and teaching strategies in SPED;
  - 2.3 To identify the roles of receiving teachers;
  - 2.4 To enhance the teachers' knowledge on the transition program; and
  - 2.5 To be familiar with the promotion and support schemes and issues on SPED.
3. The participants in this training are the regular permanent and MLSB/PLSB teachers who will teach the SPED pupils/students and the receiving teachers of Graded SPED pupils/students in the elementary and secondary school from CD 1 to 4.
4. The participants, trainers and facilitators in this training shall be entitled to service credits in accordance with DepEd Order No. 53, s. 2003 entitled Updated Guidelines on Grant of Vacation Service Credits to Teachers. Nonteaching Staff shall be provided with Compensatory Time Off (CTO) in accordance with DBM Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered.
5. Travel expenses of teachers, trainers, and management staff shall be charged to local/school funds subject to the usual accounting and auditing rules and regulations.
6. Immediate dissemination of the content of this memorandum is earnestly desired.
