SEARCH FOR THE BEST SCHOOL LEARNING RESOURCE MANAGEMENT AND DEVELOPMENT SECTION (LRMDS) IMPLEMENTER

1. The Department of Education, Schools Division of Nueva Ecija through the Curriculum Implementation Division (CID) - Learning Resource Management and Development Section (LRMDS) shall conduct the *Search for the Best Learning Resource Management and Development Section (LRMDS) Implementer* for calendar year 2018 which is open to all elementary and secondary schools. The evaluation shall start on October 9, 2018.
2. The activity aimed to:
 - a. fortify the development and availability of contextualized learning resources in the District / School LRMDS;
 - b. reinforce the accessibility to learning, teaching, and professional development resources in digital format and locates resources in print format and soft copy;
 - c. ensure that the services and utilization of the LRMDS conforms with the Deped standards;
 - d. intensify the accessibility to Supplemental Learning Resources through active participation to the LR Portal; and
 - e. strengthen the preservation of all LRMDS learning resources collection, services of information technology facilities, linkages and networking with the stakeholders.
3. There shall be two (2) categories for the search:
 - a. Best School Learning Resource Management and Development Section (LRMDS) Implementer for the elementary level
 - b. Best School Learning Resource Management and Development Section (LRMDS) Implementer for the secondary level


For the elementary level, each district shall identify one (1) official entry for the competition while for the secondary level, interested secondary schools shall accomplish and submit official entry form. Deadline of submission is on September 21, 2018.
