1. This is to announce the **Division Ranking for Special Education Teacher (SPET I) Positions for School Year 2018-2019.**
2. **DepEd Order No. 7, s. 2015** entitled **“Hiring Guidelines for Teacher I Positions Effective School Year 2015-2016”** shall be used as the primary policy in the evaluation and selection of **SPET applicants.**
3. Interested applicants may submit their written application with the supporting documents which are arranged properly according to the given list specified in the **paragraph 5.2 of DepEd Order No. 7, s. 2015** to the head of the elementary or secondary school **on or before March 2, 2018.**
4. Each applicant shall also submit certification of grades indicating the computed General Weighted Average (GWA) duly signed by the College/University Registrar from the school where they obtained their Bachelor’s Degree.
5. Each school (both in the elementary and secondary) shall have its Screening Committee to scrutinize the completeness, validity and authenticity of the submitted documents of each SPED teacher applicant. The school shall forward the application and documents to the SDO’s Record Section **on or before March 9, 2018.**
6. The schedule of demonstration teaching, interview and demonstration of specialized skills of the applicants shall be at Talavera North Central School on April 17, 2018.
